Subject: Mandatory implementation Skill Education and Kaushal Bodh textbooks in classes VI-VIII in CBSE Schools w.e.f. academic session 2025-2026

Dear Principal

This is with reference to the CBSE Circular No. Acad-29/2024 and Circular No. Acad-12/2025 regarding availability and implementation of the new competency-based textbooks published by NCERT aligned with the vision of NEP-2020 and NCF-SE -2023.

Vide the above-mentioned circulars, the schools were informed about the availability of the new textbooks by NCERT and were also directed to implement these textbooks in their schools. But it has been observed that the schools are yet to do so. The same has been viewed very seriously by the Competent Authority. **Therefore, all schools affiliated with the Board must ensure implementation of the new textbooks for Skill Education in their schools immediately in the present session i.e. 2025-2026, itself.**

The NCERT textbooks for Skill Education (i.e. the Kaushal Bodh series), is available in print version can also be downloaded from the NCERT website as well as from the CBSE academic website.

Suggestive guidelines for implementing mandatory Skill Education in classes VI-VIII using the 3 Kaushal Bodh textbooks of NCERT w.e.f. the Academic session Year 2026-27

- Rollout** - NCERT's *Kaushal Bodh* textbook to be introduced as a pre-vocational subject for Classes 6-8 starting from the academic year 2026-27.
- Curriculum Integration** – As per NCF-SE 2023, 110 hours of skill education (Approx. 160 periods per year) must be integrated into the academic timetable. Schools must allocate two consecutive periods, twice a week excluding time for exams.
- Project-Based Learning Approach** – Students will engage in three projects per Class covering: **work with life forms; work with materials & machines; work on providing human services** (1 project per form of work). By the end of Class 8, each student will have completed 9 projects across 3 forms of work. The emphasis here is for students to acquire the skills required to do the project and learn from the 'doing', and not on the end-product or end-outcome of the project.
- Selection of Projects by Schools** – Projects should ensure hands-on skill exposure across different work domains. Each *Kaushal Bodh* textbooks have 6 projects (2 for each form of work) from which schools can choose one project from each form of work per Class. Interested schools may also create their own projects as per the guideline provided in Annexures 1 - 3 of *Kaushal Bodh* textbook. The selection of projects must consider the context of the school, locality, and availability of required resources.
- Teacher Identification & Training** – Schools must designate teachers in charge of the projects for each Class, selecting from existing pool of teachers teaching academic subjects that are most aligned to the projects either by their subject or by their own interest area. If a separate Vocational Education Teacher is available, other teachers will complement the work. CBSE shall provide training to these teachers.
- Resources for Implementation** - Schools with Composite Skill Labs (CSL) or other relevant labs may utilize relevant tools and equipment for the projects. They may also procure the required tools and equipment which may later be incorporated into the CSL. Schools can also design projects related to vocations available around the school, so that local experts in the community can be engaged and students can be taken on field visits.
- Student Assessment & Showcase** – Student learning will be evaluated through project-based assessments. Schools are advised to integrate this assessment into the Internal Assessment, with the marks to be added in the final examination. A suggested weightage and marking scheme for Assessment & Evaluation is provided below:

Mode of Assessment	Weightage
Written Test	10%
Oral Presentation/ Viva Voce	30%
Activity Book	30%
Portfolio	10%
Teachers' Observations during Activities	20%

Summative Assessment to be done at the end of each project to evaluate students' achievement and what are the pathways to the next stage of learning.

- Kaushal Mela (Skill Fair)** should be organized in the school at the end of the academic year to showcase skills students have learnt through their projects.
